TRUTHFULNESS SCALE: MEDIUM RISK RANGE

This client's Truthfulness Scale score is in the Medium Risk (40 to 69th percentile) range. This is an accurate TII profile, in spite of this person's attempts to deny common problems. This client tends to be guarded, defensive and self-protective regarding self-disclosure. Although some denial is present, truth-corrected scores are accurate. TII results may reflect an unintentional passive-aggressive attitude. Stress may also exacerbate defensiveness.

ANXIETY SCALE: PROBLEM RISK RANGE

This client's Anxiety Scale score is in the Problem Risk (70 to 89th percentile) range. Feelings of insecurity, tension, uneasiness and apprehension are evident. Anxiety is an unpleasant emotional state, often involving nervousness and a sense of threat. Anxiety is a problem. Consideration might be given to counseling. This person's Alcohol Scale score is in the Low Risk (zero to 39th percentile) range. Few, if any, indicators of alcohol (beer, wine or liquor) abuse are evident. Alcohol use, if present, may be historical, experimental or social in nature and represent minimal involvement. Alcohol-related problems do not appear to be focal issues. A person who does not drink may score above zero, but would still be in the low risk range. This is a low risk Alcohol Scale score.

DRUGS SCALE: PROBLEM RISK RANGE

This client's Drugs Scale score is in the Problem Risk (70 to 89th percentile) range. Drug-related problems are indicated. Either this client has a drug problem or is a recovering (drug problem, but has stopped using) drug abuser. A pattern of drug abuse is becoming evident. Drug-related treatment or counseling appears waranted. And, participation in Narcotics Anonymous (NA) or Cocaine Anonymous (CA) could be helpful. Relapse is possible. This is a problem risk Drugs Scale score.

STRESS COPING SCALE: MAXIMUM RISK RANGE

This client's Stress Coping abilities Scale score is in the Severe Problem (90 to 100th percentile) range. Poor stress coping abilities are evident. This client has serious stress coping problems. Disorganization under stress is likely. Stress is exacerbating other problems. This client needs counseling. Serious stress coping problems exist. This is a maximum risk score.

SELF-ESTEEM SCALE: MAXIMUM RISK RANGE

This client's Self-Esteem Scale score is in the Severe Problem (90 to 100th percentile) range. Low self-esteem is evident. High risk scorers reveal pervasive negative self-evaluations, negative expectations and disapproval of oneself. Emotional and social isolation, sensitivity to perceived rejection, and impaired social skills are likely. This client would benefit from emotional support of endeavor and counseling. This is a high risk score.

DISTRESS SCALE: PROBLEM RISK RANGE

This person's Distress Scale score is in the Problem Risk (70 to 89th percentile) range. Problem risk scores typically reflect considerable worry, apprehension and unhappiness. This is a troubled client. Feelings of dependency and suicidal ideation should be explored in interview. Other areas of inquiry might include this person's life situation, adjustment and emotional equilibrium. This individual is experiencing considerable distress and is not coping with it well.

FAMILY ISSUES SCALE: PROBLEM RISK RANGE

This client's Family Scale score is in the Problem Risk (70 to 89th percentile) range. Problem risk scorers are typically aware of family conflict, impaired communication within the family group, and disharmony. Interpersonal interaction within the family group should be explored in subsequent interview. The person's attitude will largely disclose the feasability of family counseling as an alternative.
